**ORDER APPROVING  
STIPULATED MODIFICATIONS  
OF SETTLEMENT TERMS [424]**

1 This Court, having considered whether to approve the stipulated  
2 modifications of settlement terms of the above-captioned action pursuant to the  
3 Second Joint Stipulation Re: Modification of Settlement Terms, having read and  
4 considered all of the papers and argument of the parties and their counsel, and  
5 good cause appearing,

6 **IT IS ORDERED AS FOLLOWS:**

7 1. The provision of services under the Jobs and Education and the  
8 Tattoo Removal Programs are extended by a further six months to June 27, 2022.

9 2. The Claim Forms shall be amended to reflect that:

10 a. the deadline for receipt of claims is December 27, 2021;

11 b. the provision of services under the Programs will continue  
12 until June 27, 2022.

13 3. The [Proposed] Third Amended Claim Form filed as Exhibit 3 to the  
14 Joint Stipulation Re: Modification of Settlement Terms, is approved.

15 4. Within 21 days of the approval of this stipulation, and entering of this  
16 Order, City shall cause the approved Third Amended Claim Form to be served by  
17 mail to all Settlement Class Members at the last known class member addresses  
18 which the City has updated since 2017.

19 5. City shall provide a Third Amended Claim Form to any Settlement  
20 Class Member who requests one.

21 6. Class Counsel shall post the Third Amended Claim Form to  
22 download at [www.gangcase.com](http://www.gangcase.com) for the duration of the injunctive relief following  
23 court approval of the Third Amended Claim Form. Class Counsel also shall  
24 provide a Third Amended Claim Form to any Settlement Class Member who  
25 requests one.
