**ORDER APPROVING

1 This Court, having considered whether to grant the stipulated  
2 modifications of settlement terms of the above-captioned action pursuant to the  
3 Third Joint Stipulation Re: Modification of Settlement Terms, having read and  
4 considered all of the papers and argument of the parties and their counsel, and  
5 good cause appearing,

6 **IT IS ORDERED AS FOLLOWS:**

7 1. The Claim Forms shall be amended to reflect that the deadline for  
8 receipt of claims is June 1, 2022;

9 2. The [Proposed] Fourth Amended Claim Form filed as Exhibit 4 to  
10 the Third Joint Stipulation Re: Modification of Settlement Terms, is approved.

11 3. Within 21 days of the granting of this stipulation, and entering of this  
12 Order, City shall cause the approved Fourth Amended Claim Form to be served by  
13 mail to all Settlement Class Members at the last known class member addresses.


14 4. City shall provide a Fourth Amended Claim Form to any Settlement  
15 Class Member who requests one.

16 5. Class Counsel shall post the Fourth Amended Claim Form to  
17 download at [www.gangcase.com](http://www.gangcase.com) for the duration of the injunctive relief following  
18 court approval of the Fourth Amended Claim Form. Class Counsel also shall  
19 provide a Fourth Amended Claim Form to any Settlement Class Member who  
20 requests one.

21 6. The Claims Administrator shall continue to receive and process all  
22 claims submitted by Settlement Class Members pursuant to the joint written  
23 instructions provided by Class Counsel and Defense Counsel.
