**ORDER APPROVING  
STIPULATED MODIFICATIONS  
OF SETTLEMENT TERMS [440]**

This Court, having considered the parties’ stipulated modifications of settlement terms of the above-captioned action pursuant to the Fifth Joint Stipulation Re: Modification of Settlement Terms, having read and considered all of the papers and argument of the parties and their counsel, and good cause appearing,

1 **IT IS ORDERED AS FOLLOWS:**

2 1. The provision of services under the Jobs and Education and the Tattoo  
3 Removal Programs shall be extended by a further twelve months to June 27, 2024;

4 2. The Claim Forms shall be amended to reflect that:

5 a. the deadline for receipt of claims is March 27, 2024;

6 b. the provision of services under the Programs will continue until June  
7 27, 2024.

8 3. The [Proposed] Sixth Amended Claim Form filed as Exhibit 6 to the Fifth  
9 Joint Stipulation Re: Modification of Settlement Terms, is approved.

10 4. Within 21 days of the approval of this stipulation, and entry of this Order,  
11 City shall cause the approved Sixth Amended Claim Form to be served by mail to all  
12 Settlement Class Members at the last known class member addresses.


13 5. City shall provide a Sixth Amended Claim Form to any Settlement Class  
14 Member who requests one.

15 6. Class Counsel shall post the Sixth Amended Claim Form to download at  
16 [www.gangcase.com](http://www.gangcase.com) for the duration of the injunctive relief following court approval of  
17 the Sixth Amended Claim Form. Class Counsel also shall provide a Sixth Amended  
18 Claim Form to any Settlement Class Member who requests one.

19 7. The Claims Administrator shall continue to receive and process all claims  
20 submitted by Settlement Class Members pursuant to the joint written instructions  
21 provided by Class Counsel and Defense Counsel.
